On the above date and time, a plainclothes Vice investigation was conducted under the direction of 5V200, Lt. Dutto #1235, myself and the listed members. See attached Vice investigation personnel sheet.

Sgt. Lawson #939 was one of the designated decoy officers and entered the above location in an undercover capacity. Sgt. Lawson was greeted by a white female dancer named "Celeste". "Celeste" was later identified as ~~C/Walker~~. ~~C/Walker~~ guided Sgt. Lawson to the back room and Sgt. Lawson was solicited for an act of prostitution by ~~C/Walker~~. For details, see the written statement prepared by Sgt. Lawson.

The cover team entered The Cinema at approximately 1627 hours and I located Sgt. Lawson and ~~C/Walker~~ at the back of the Cinema. Sgt. Lawson and ~~C/Walker~~ were inside the Bangkok room, booth #17. Sgt. Lawson and I identified ourselves as police officers and I took ~~C/Walker~~ into custody. Sgt. Lawson told me that he paid ~~C/Walker~~ \$220.00 in Marked City Funds and \$80.00 from his own money. I recovered the \$300.00 from ~~C/Walker's~~ purse. I also saw \$1,042.00 dollars and six condoms inside ~~C/Walker's~~ purse. I spoke to ~~C/Walker~~ and ~~C/Walker~~ told me that she has been working at the Market Street Cinema for approximately 14 months. ~~C/Walker~~ said she usually works 4 to 5 days a week. ~~C/Walker~~ said she only works 4 hours each shift from 1 pm to 5 pm. ~~C/Walker~~ said she has to pay a \$200.00 stage fee each shift. ~~C/Walker~~ said it's also customary for dancers to "tip down" to the D.J., cashiers, and other none management workers. "Tip down", meaning paying the other none management workers a portion of her earnings. ~~C/Walker~~ said she does not get any wages from management and works only for tips (US currency that customers give her from dancing on stage), lap dances (when she goes to the customer's seat and dance directly in front of the customer straddling his lap. The minnum cost for a lap dance is \$20.00) and private sessions (when she performs lap dances for customers in a private booth). I asked ~~C/Walker~~ regarding the computerized money receptacle machine in the private booth and ~~C/Walker~~ told me that the customer has to pay to use the private booth. ~~C/Walker~~ said it costs \$20.00 for five minutes and she gets half of the profits. ~~C/Walker~~ said when she brings a customer to the private booth, she notifies the clerk or the cashier at the entrance of the back room to keep track of the earnings.

I told ~~C/Walker~~ I'd like to talk to her about this incident (the solicitation with Sgt. Lawson) and mirandized C/Walker. C/Walker declined to make any statement regarding this incident.

I cited and released ~~C/Walker~~ at the scene.

Lt. Dutto took digital photos of C/Walker, the private booth and the evidence.

Inspector Stocker recovered the twenty dollar bill from the front entrance fee and the ten dollar bill from the admission fee to the Bangkok room.

The evidence were booked as listed.

ON TODAY'S DATE, AN UNDERCOVER PROSTITUTION OPERATION WAS CONDUCTED AT THE "MARKET ST. CINEMA" LOCATED AT 1077 MARKET ST. I WAS DESIGNATED AS ONE OF THE UNDERCOVER DECOYS AND WAS SUPPLIED WITH MARKED CITY FUNDS.

I ENTERED THE PREMISE AND THE FRONT CASHIER CLERK STATED THAT THERE WAS A TWENTY DOLLAR COVER CHARGE. I PAID TWENTY DOLLARS IN MCF AND WALKED THROUGH ANOTHER DOOR TO THE MAIN STAGE AREA. AT THIS TIME THERE WAS NO DANCER ON STAGE. I THEN BEGAN TO WALK DOWN THE LEFT AISLE OF THE THEATER WHEN I WAS APPROACHED BY A WHITE FEMALE, INTRODUCING HERSELF AS "CELESTE". CELESTE WAS WEARING A FLORAL BIKINI TOP AND A FLORAL BIKINI BOTTOM. SHE THEN PLACED HER ARMS AROUND ME AND GAVE ME A HUG AND SHE THEN ASKED, "HAVE YOU BEEN HERE BEFORE. "I REPLIED, "NO, BUT A FRIEND OF MINE WAS HERE AND HE HAD A GREAT TIME". SHE THEN STATED, "COME WITH ME AND I'LL SHOW YOU AROUND". SHE HAD HER ARMS AROUND ME DURING THE CONVERSATION. SHE THEN TOOK MY HAND AND GUIDED ME DOWN THE AISLE TO THE ENTRANCE OF ANOTHER ROOM (BANGKOK ROOM) IN THE THEATER. I WAS MET THERE BY ANOTHER CASHIER CLERK. CELESTE STATED I HAD TO PAY ANOTHER TEN DOLLARS TO GAIN ENTRY. I PAID THE CLERK WITH MCF. I WAS GIVEN TWO YELLOW TICKETS AND HAD TO APPROACH ANOTHER CLERK GIVING HIM THE TWO TICKETS. THE CLERK GAVE ME ONE BACK AND THEN STAMPED THE BACK OF MY HAND. CELESTE AGAIN TOOK MY HAND AND WALKED ME OVER TO A PRIVATE BOOTH #17. SHE OPENED UP THE CURTAIN AND TOLD ME TO COME AND SIT DOWN ON THE PADDED BENCH. THERE WAS AN ELEVATED PADDED PLATFORM ABOUT TWELVE INCHES FROM THE BENCH WHERE I WAS SITTING. ONCE INSIDE SHE CLOSED THE CURTAIN, STOOD DIRECTLY IN FRONT OF ME AND BEGAN RUBBING MY CHEST, ARMS, AND GROIN AREA. SHE ALSO BEGAN RUBBING HER BREASTS. SHE THEN WHISPERED IN MY EAR, "WE CAN BE NAUGHTY IN HERE ("NAUGHTY" IS A PROSTITUTION SLANG TERM-SEX FOR MONEY." BASED ON MY TRAINING AND EXPERIENCE. SHE WHISPERED AGAIN IN MY EAR THAT SHE WOULD DANCE FOR ME, TAKE OFF HER CLOTHES, AND MAKE ME FEEL REAL GOOD. SHE THEN STATED THAT SHE NEEDED FORTY DOLLARS FOR THE BOOTH. I THEN HANDED HER FORTY DOLLARS IN MARKED CITY FUNDS. SHE ASKED ME FOR A "TIP" FOR HERSELF. I THEN HANDED HER SIXTY DOLLARS IN MARKED CITY FUNDS. SHE THEN STATED THAT SHE HAD TO LEAVE FOR A MINUTE, BUT SHE WOULD BE RIGHT BACK.

UPON RETURNING TO THE PRIVATE BOOTH SHE CLOSED THE CURTAIN. SHE THEN TOOK OFF HER FLORAL BIKINI TOP EXPOSING HER BARE BREASTS. AS I WAS SITTING ON THE PADDED BENCH SHE SAT ON MY LAP FACING ME WITH HER KNEES ON THE PADDED BENCH. SHE THEN BEGAN RUBBING HER BREASTS. SHE THEN RUBBED MY LEGS AND MY GROIN AREA AND ASKED ME IF I WAS GETTING HARD. I THEN ASKED HER IF I COULD GET A HAND JOB. SHE THEN REPLIED, "WE CAN DO THAT, OH DEFINETLY." I THEN ASKED HER IF I COULD GET A BLOW JOB. SHE SAID, "OH YEAH SURE." I THEN ASKED HER HOW MUCH WAS A BLOW JOB. SHE STATED, "TWO HUNDRED DOLLARS, AND IF YOU NEED MORE MONEY THERE IS AN ATM MACHINE OUTSIDE THIS BOOTH." I THEN TOLD HER THAT I DID NEED TO GO TO THE ATM MACHINE. WE BOTH WALKED OUTSIDE THE BOOTH TO THE ATM MACHINE. ONCE AT THE MACHINE I TOLD HER I HAD ENOUGH CASH IN MY POCKET TO PAY HER. WE BOTH RETURNED TO OUR PRIVATE BOOTH. ONCE INSIDE THE BOOTH I HANDED HER ONE HUNDRED AND TWENTY DOLLARS IN MARKED CITY FUNDS AND EIGHTY DOLLARS OF MY OWN MONEY. AFTER SHE TOOK THE MONEY SHE BEGAN TO AGGRESIVELY TOUCH MY GROIN AREA AGAIN SO I THEN IDENTIFIED MYSELF AS A POLICE OFFICER AND PLACED HER UNDER ARREST. AS I ATTEMPTED TO NOTIFY MY COVER OFFICERS I REALIZED LT. DUTTO AND MY ARREST TEAM WERE ALREADY INSIDE THE PREMISE.
