On todays date at 1658 hours, I along with Inspectors from the Vice Crimes Division responded to 816 Larkin Street to conduct a Vice investigation. I was assigned as the undercover Officer, and my close cover team were Inspectors Ziegler and McNaughton. Once inside,I saw several women scantily attired in G-strings and see through tops. After approximately 2 minutes, a young woman came up to me and ask if I wanted a good time (prostitution slang for sex for money). I asked what she meant by a good time. She told he that she would take me to a back room and "rock my world" . She then took me to a back room area which was very dark. There were several rooms with heavy curtains. She took me to the "Geisha Girl " room , the heavy curtains were pulled to the side as we entered the room. I noted that the room had a padded bench and a table with a lamp next to it. On the wall of the room was a towel and a soap dispenser. She then asked me for \$200.00 two hundred dollars. I asked what the two hundred dollars was for. She told me everything(prostitution slang for oral copulation and sexual intercourse). She futher stated that she would have sex with me for the money. I told her that I only had \$190.00 on me as I paid \$10.00 for the entrance fee. She told me that \$190.00 would do. She then told me to sit back and she would do everything as she closed the curtin to the room. At this time I gave her \$ 190.00 in marked city funds. She then took the money from me and placed it inside her purse. At the same time she took out a condom from her purse and opened it . She then took out a 2.5oz of K Y lube from her purse and placed a drop on the condom. She then placed the condom on the table. She then turned around and placed one of the \$20.00 dollar bills of marked city funds into the money receptacle machine which was mounted on the wall. She then took a key of some type and placed it inside the money receptacle machine. I noted that the display on the money receptacle machine had a digital display,10 minute timer and had the name for the display: I then asked what else does she do? She told me that for another one hundred dollars, she would have anal sex with me. I told her that I did not have anymore cash on me. She told me that I could use the ATM on the second floor. She then told me that she would walk me to the ATM. At this time I gave the signal for my cover team to respond. The Inspectors came in and detained the woman. The marked city funds were recovered by Officer Rolovich. Inspector Ziegler then took over the investigation from this point,

ON TODAYS DATE A PLAIN CLOTHES VICE INVESTIGATION WAS CONDUCTED UNDER THE DIRECTION OF LT. DUTTO #1235, MYSELF AND MEMBERS OF THE VICE CRIMES DIVISION. SGT CHEUNG ENTERED THE NEW CENTURY THEATER IN AN UNDERCOVER CAPACITY AND WAS SOLICITED FOR AN ACT OF PROSTITUTION BY C-1 CHEUNGS STATEMENT).

MINISTERING GAVE OFC ROLOVICH A SPONTANEOUS STATEMENT (SER OFC ROLOVICHS STATEMENT). I MIRANDIZED STATEMENT AND SHE SAID SHE UNDERSTOOD HER RIGHTS AND WOULD SPEAK TO ME. I TAPE RECORDED THIS INTERVIEW. GROWING TOLD ME HER STAGE NAME TODAY WAS THE ASIAN MAN (SGT CHEUNG), AND HAD A DISCUSSION REGARDING SEX FOR MONEY AND AN AGREEMENT. HE GAVE ME \$190 AND WE AGREED IT WOULD BE \$200 FOR EVERYTHING. I TOOK HIM IN A ROOM AND SHUT THE CURTIN. I THEN HUSTLED HIM FOR MORE BY GOING TO THE ATM AND TELLING HIM WE COULD DO SOMETHING REALLY NASTY AND HAVE A KINKY TIME. I ASKED HER IF THAT MEANT ANAL SEX AND SHE SAID THAT WAS THE UNDERSTANDING. BECKERG SAID THAT SHE WAS NOT GOING TO HAVE SEX WITH THE MAN, BUT THAT SHE WAS GOING TO TELL HIM IT WAS ALL A FANTASY AND HAVE THE MAN MASTERBATE. SECOND SAID SHE PULLED A CONDOM OUT OF HER PURSE, OPENED IT AND PUT SOME LUBE ON IT. STORES EXPLAINED THAT SHE PUT E-9 \$20 FROM THE MAN IN THE METER MACHINE AND SHE USED HER CODE KEY BEFORE SHE PUT THE MONEY IN. THE TIMER STARTS AND IT COSTS ANOTHER \$20 AFTER 5 MINUTES. IF SHE DOESN'T PUT MORE MONEY IN THE CUSTOMER WILL HAVE TO LEAVE THE ROOM. THE ROOM CAN BE BOUGHT FOR AN HOUR BUT WAS NOT SURE HOW MUCH IT COSTS. STORES TOLD ME SHE NEVER HAS SEX WITH THE CUSTOMERS. I ASKED HER IF THE MANAGEMENT PROVIDED CONDOMS AND SHE SAID SHE PROVIDED HER OWN. SPONDENCE WAS CITED AS PER ABOVE.

OFC ROLOVICH RECOVERED THE \$170 MCF FROM STOMBERES PURSE. I RECOVERED THE \$10 ENTRANCE FEE MCF FROM THE CASH REGISTER AT THE THEATER ENTRANCE. I WAS UNABLE TO RECOVER THE E-9 \$20 MCF THAT STORMER PUT IN THE MONEY RECEPTACLE MACHINE IN THE ROOM. SGT CHEUNG RECOVERED THE E-5 CONDOM FROM THE TABLE IN THE GEISHA GIRL ROOM. I RECOVERED THE E-6 KY LUBE FROM STOMBERES PURSE. LT DUTTO TOOK DIGITAL PHOTOS OF THE SCENE AND C-1 STORMER.

Sgt. Cheung #960 arrested (C) Stoneling at 816 Larkin St. for solicitation of prostitution. I assisted Sgt. Cheung with his arrest. When I searched (C) Stoneling I asked her for her identification when she began to speak to me spontaneously. (C) Stoneling told me that she was not a prostitute. She stated that she was a "hustler". She told me that once she puts her key into the computerized money receptacle machine inside the booth, she has to put in a \$20.00 bill every twenty minutes. Stoneling said she tells the "John" that the \$20.00 is good for twenty minutes of her time. However the management has the machines set to buzz every five minutes, to fool the "John" into believing that the twenty minutes is up. Therefore, since she has to feed the machine every five minutes, this means that she must get more money from the "John" anyway she can. She said that in order for her to make any money for herself, she pockets the money which was agreed on for any sex act.

She was then Mirandized and interviewed by Inspector Zeigler # 1020.
